 - DATCP/UW Nutrient Management Workshops (Dan Marzu): Combo DATPC/UW presentations on SNAP Plus version 3, cover crops, 3-hour workshop in areas around the state <u>https://datcp.wi.gov/Pages/Programs_Services/NutrientManagementTraining.</u> <u>aspx</u>
 - Southeast (Ryan Glassmaker): Advanced Conservation Planning Training (~50 people), evaluated that the content may have been more in-depth than necessary, so we're looking to add some more basic trainings later this year, also looking for advanced CNMP training, embankment practices, adding a few more trainings later this year: GPS, grazing, pipeline; advanced CNMP walkover at farm(s) for newer folks
 - 3. **Southwest (Kelli Neitzel):** Virtual training for manure stacking facilities, Carlson (?) GPS meetings (Baraboo or Dells to encourage higher attendance)
 - 4. **Northeast (Drew Zelle):** Grassed waterway training last week (21 people, many new folks from RC and D), technical tour in Manitowoc County, limited training because of late field season start
 - 5. *Northwest (Pete Wurzer):* Grassed waterway training, rock gradation training at a quarry, new faces becoming more familiar hopefully getting more stable

with turnover and new staff, pushed off training until September/October – backhoe training and concrete inspection training in fall or early next year (more advanced) – setting it up so it could be used as statewide training

- 6. **North (Stacy Dehne):** Group of technicians on July 6th to hear speaker from US Forest Service, looking for a training on 9 key element training through grant with focus on protection rather than restoration efforts, grant due end of June
- Mike Stanek (NRCS): Nutrient Management Workgroup in late August, Farmtech Days in July, Partnering with Sand County for Prairie Strips training to modify seeding mixtures in July 25-26 in Vernon and Dodge counties, Midwest Manure Expo in August
- 8. Kevin Erb (UW-Ext.): North American Manure Expo at Arlington in August will have different separators and treatment systems operating on the site and agitation demos, a safety school, and releasing a drag line (manureexpo.com), no charge for education sessions or demonstrations, also doing tours, great opportunity for newer staff; working with NRCS on virtual (not in AgLearn) and in-person gully training

 - a. Interagency goes beyond what we can train on alone, SITCOM goes beyond the limits of area, importance of connecting to outside contacts, SITCOM training as universal
 - 2. Dan/Emily/Isabelle/Karl
 - a. Interagency from perspective of the audience a training has a broader appeal than just one organization (although it may be delivered by one group), we raised a question on if a training is developed by SITCOM or is promoted by SITCOM
 - 3. Mike S./Ryan/Stacy/Drew
 - a. Traditionally defined as the agencies working together, but should also involve private consultants and adjacent agencies (whatever group of people that are involved), interagency can keep us in a box but in many trainings we rely on outside involvements (like how NRCS brings in Kevin Erb), SITCOM = state level umbrella as promotion or support
 - Emily I've heard complaints from private consultants regarding inconsistencies in review processes (could potentially be a training topic as a raised concern)
 - Ryan common problem as you could have 3-4 different agencies with different process, we could work start small by coordinating DNR and LCDs for example to find common ground
 - 2. Stacy It's difficult sometimes to find what should be a statewide training, but this should truly be a

statewide training (focused on consistency and how to review), the trouble is that sometimes people can get off on a tangent
